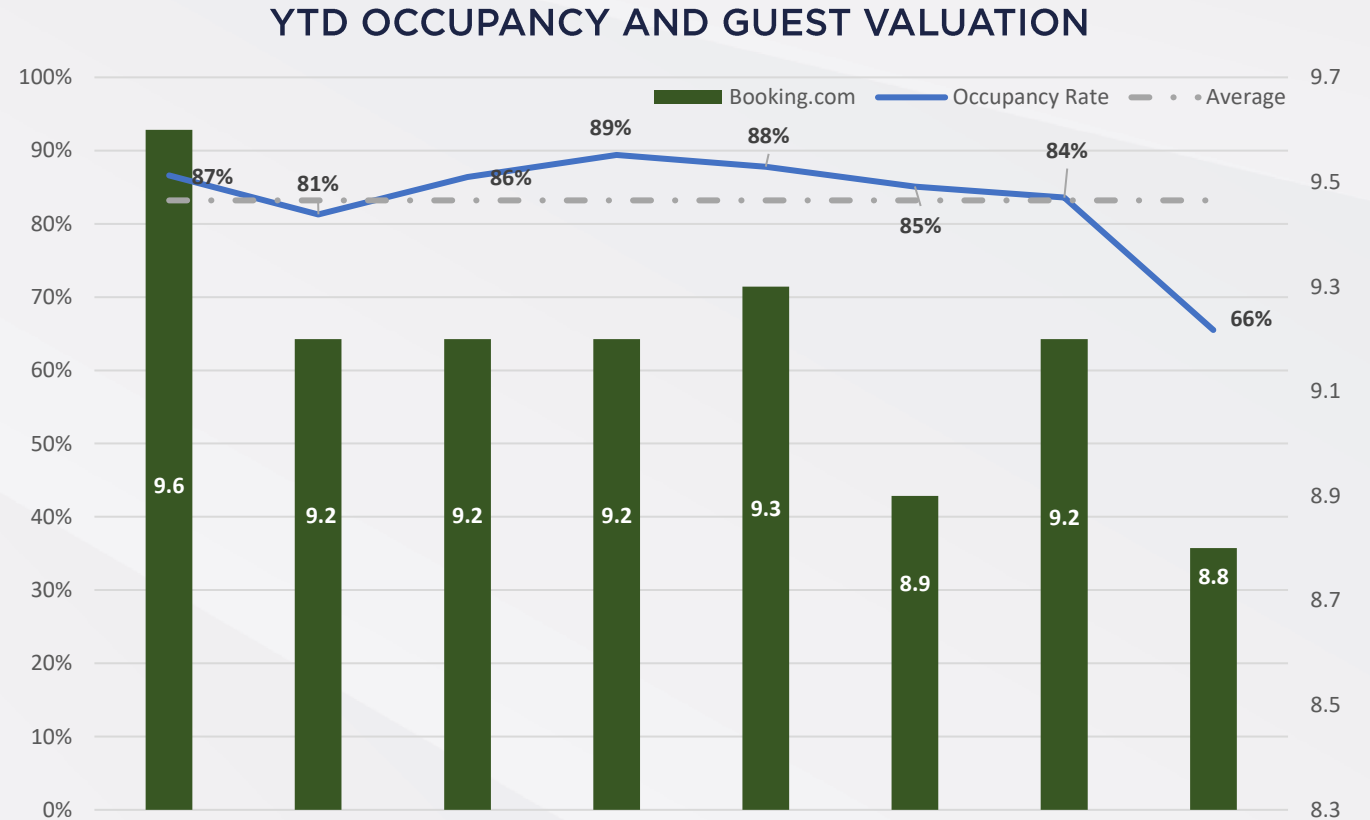
## PORTUGAL HOSPITALITY MARKET

**Overnight stays in tourism increased by 8.5% in October**

The tourist accommodation sector recorded **7.4 million overnight stays in October**, 8.5% more than in the same month of 2022, mainly due to foreign markets. In the flash estimate of tourism activity, guests also increased in October, in this case by **8.7% to 2.9 million**.

**1.** *Creation of at least 10 jobs.*



**2.** *Minimum 500.000 €, applied in research activities.*



**3.** *Donation of minimum 250.000€ - for Arts, National Heritage and Culture.*

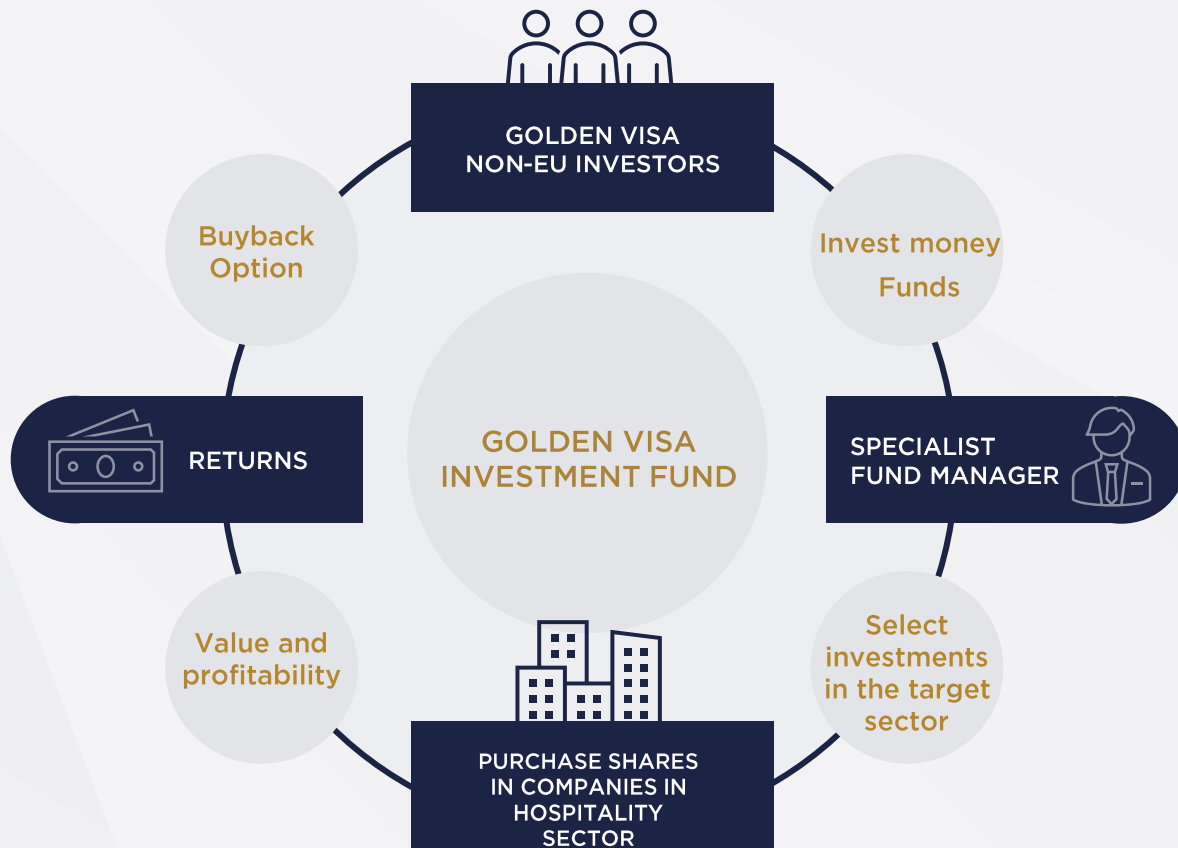

# What is a Private Equity Investment Fund?



A Private Equity Investment Fund in Portugal is a specialized investment vehicle that pools capital from investors to acquire and manage private companies, aiming for profitable exits.

The investment strategy of Funds is focused in hospitality sector in Portugal.

Funds shall invest in companies with a high potential for growth, appreciation on in value and profitability, operating in the hospitality sector, targeting co-investment opportunities, that promise appreciation in value over time, leveraging the group's deep market insight and operational expertise.

Investors can look forward to a diversified investment experience, with holdings spread across various hotels projects within the fund's scope.

Commitment to the funds is designed to be in line with the prerequisites of the Portuguese Golden Visa program, with a minimum investment amount of 500,000€, providing an attractive avenue for non-EU investors seeking Portuguese residency benefits along with financial returns.

Additionally, the Funds underscore investor confidence with a buyback option, enhancing investment security.

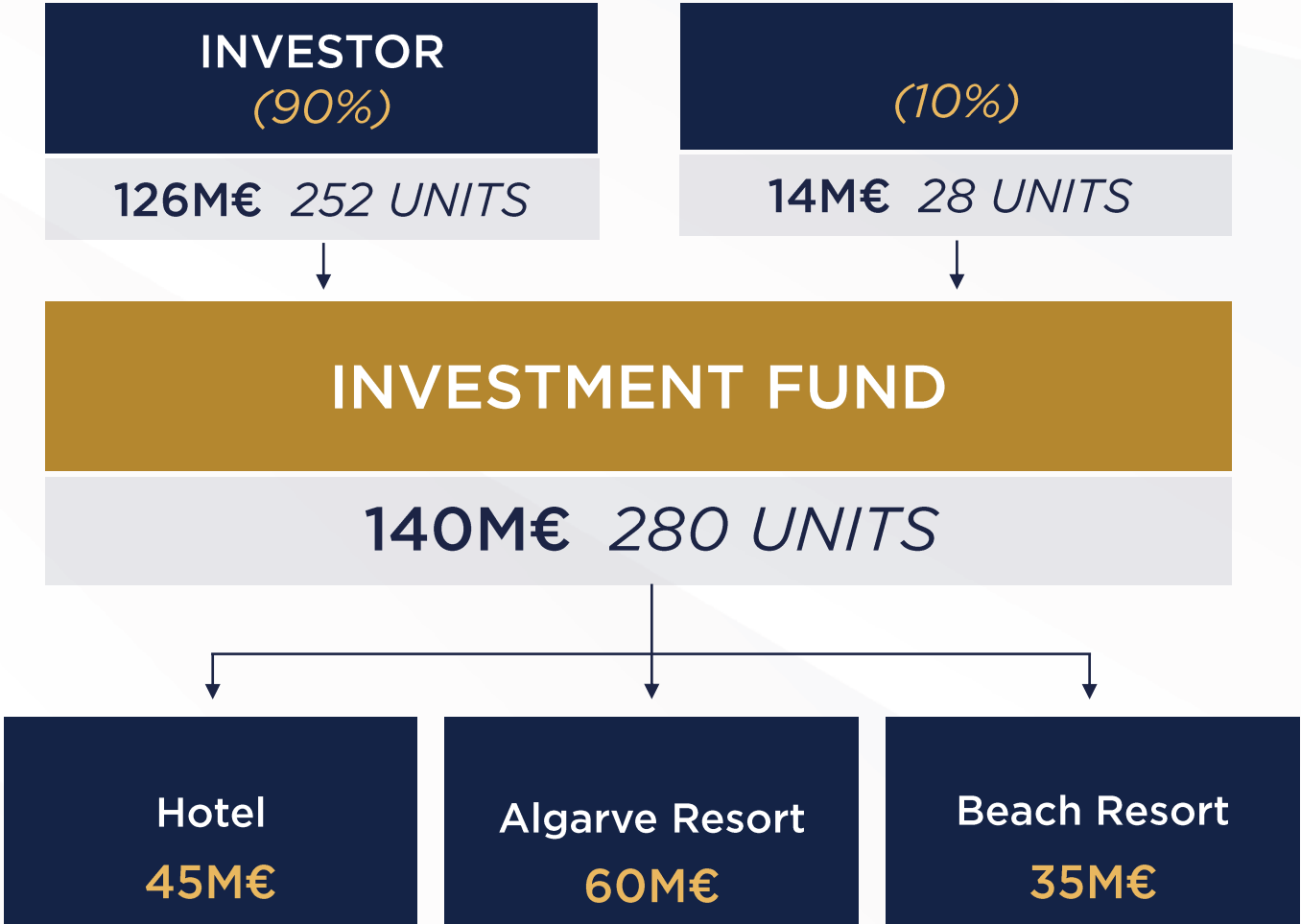

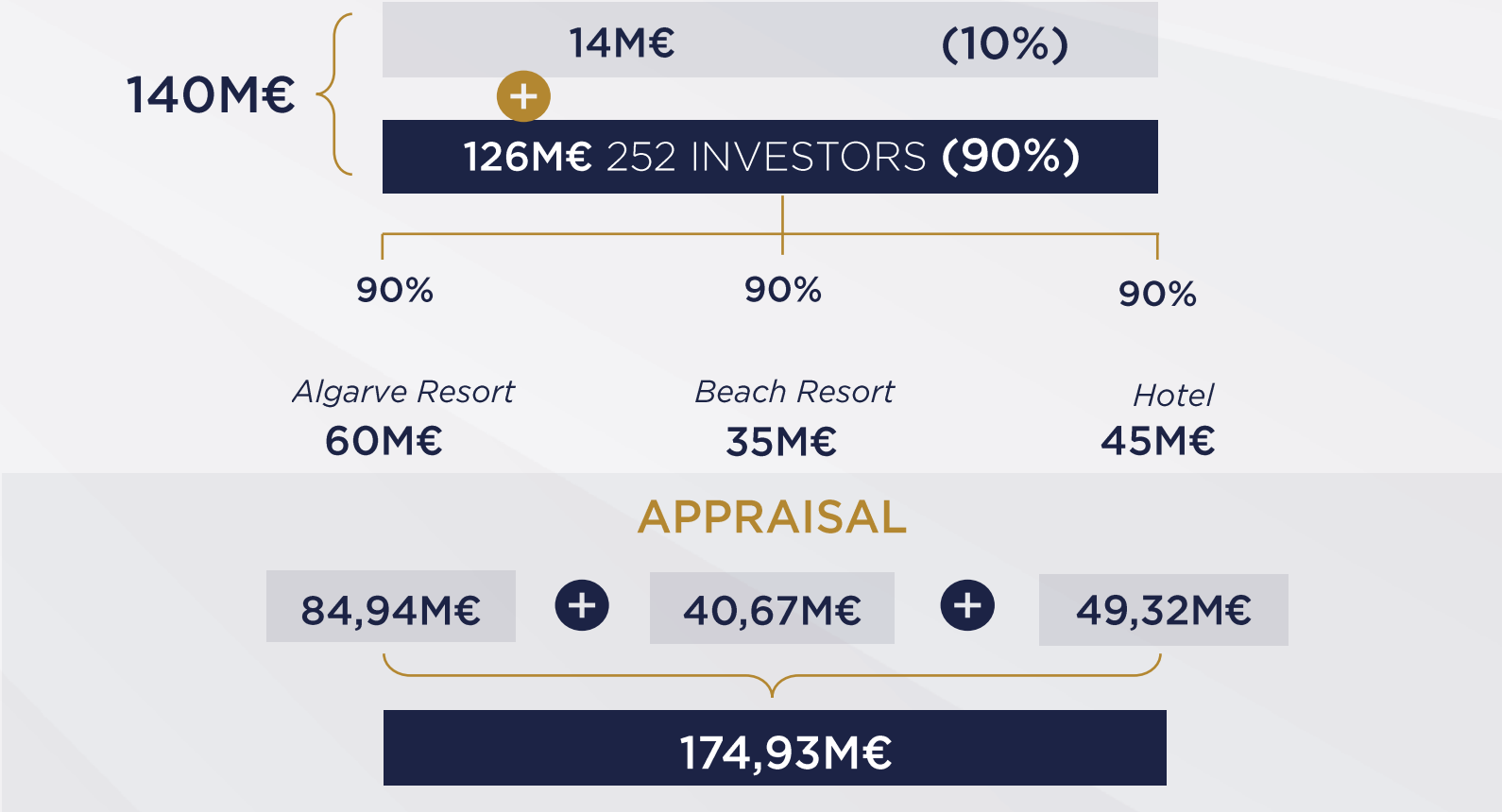

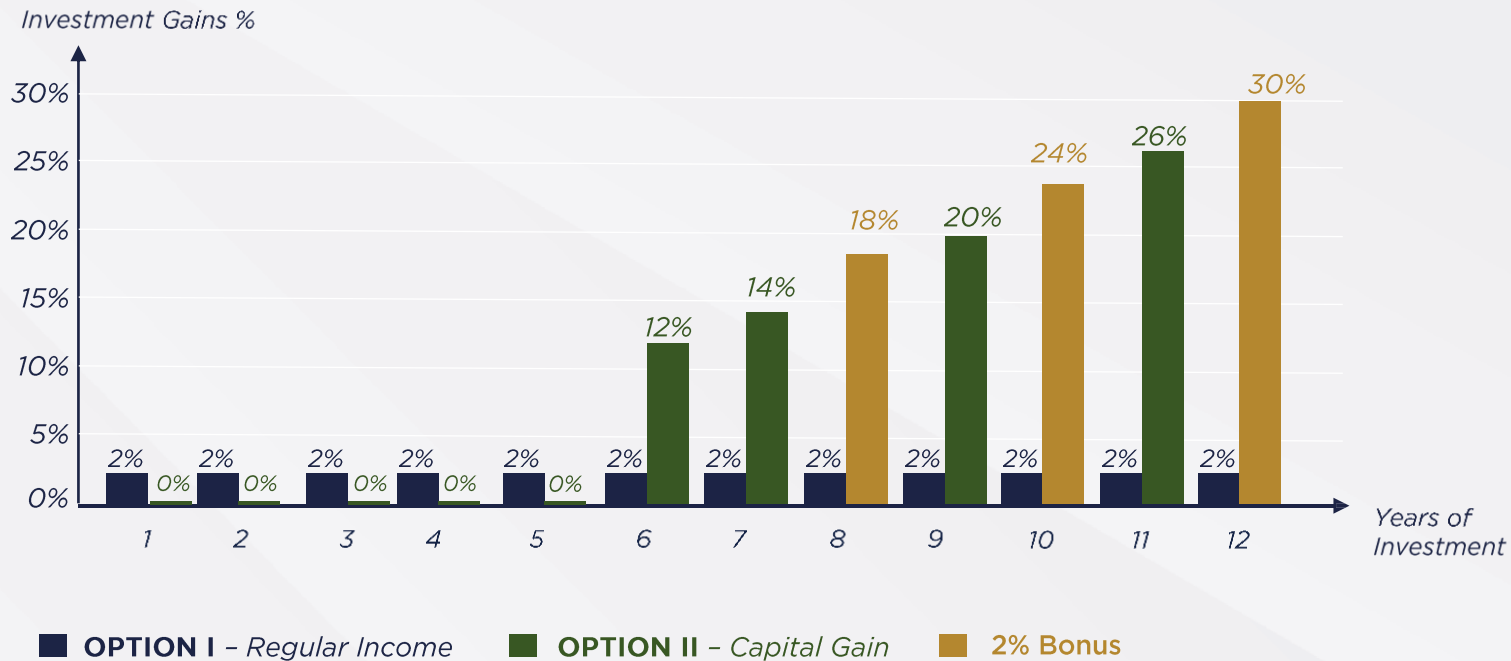

### OPTION I

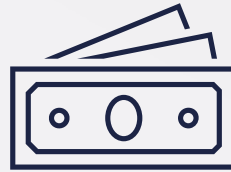
